

EDUCATIONAL DIGITAL SITE LICENSE AGREEMENT

The following is the License Agreement (the "Agreement") between Five Seasons Media LLC ("Producer"), and the entity named on the attached Invoice ("Licensee"), in connection with the licensing of the documentary motion picture entitled *Five Seasons: The Gardens of Piet Oudolf* (the "Film"). Licensee agrees to the following terms and conditions by completing payment of license fee and accepting delivery of the Film copy.

LICENSE TERMS

The Licensee is granted online streaming access from the Producer of the Film, *Five Seasons: The Gardens of Piet Oudolf* (75min documentary).

The Licensee may encode a digital file hosted on local network. Content may not be altered or edited in any manner. Digitized material is for streaming (multiple user, video- on-demand format) only and content may not be copied to any other format or used for any purpose not outlined in this agreement.

The Licensee must guarantee a password-protected environment without the ability of a user to download the film. Licensees may then deliver the contents of these files via password- protected digital streaming link only to registered students, accredited researchers, faculty and staff of the Licensee.

The Licensee may video stream content only for students in an educational setting (i.e. for non-paying audiences only). Public performances or screenings are not permitted with this license.

Five Seasons: The Gardens of Piet Oudolf film and video content is protected by United States copyright law. Duplication, reproduction, alteration, television broadcast or cablecast, (except for on- campus closed circuit), loaning for a fee, leasing, sublicensing to others or use for any commercial purposes (i.e. charging admission) is strictly prohibited without express written permission from Five Seasons Media LLC.

The term of this license shall be for the life of the file format. The files may be securely stored for archival purposes, but in the event that the licensing institution decides to change file formats, then this agreement must be renegotiated before the film is re- encoded, or new transcodes made and streaming of the film resumed.

PAYMENT AND DELIVERY

Licensee shall pay the Producer a non-refundable fee (the "License Fee") plus shipping charges and sales tax, applicable to the Licensee at the time of receipt of invoice, payable by credit card, paypal or check. Following receipt of License Fee a download link to the digital file will be provided. Licensee shall notify Producer in writing of any issues with the download link within 15 days of receipt.

LIMITATIONS OF LIABILITY

In the event that the Film delivered is defective in any way Producer shall be solely liable to replace such Film in a timely manner. Producer shall have no other obligations and/or liabilities to Licensee.

LICENSEE WARRANTIES AND REPRESENTATIONS

Licensee warrants and represents that (a) the person listed on the invoice is authorized to bind it to the terms of this Agreement; (b) the titles, credits, copyright, and trademark notices appearing in the Film delivered by Producer to Licensee will appear unaltered in all exhibitions of the Film by the Licensor; (c) it will not use, distribute, or exploit or authorize the use, distribution, or exploitation of the Film in any manner not specifically authorized hereunder.

RESERVATION OF RIGHTS

The Licensee understands and agrees that the Film is being licensed on a non-exclusive basis for use by Licensee only for educational purposes, with the copyright of the Film remaining with the Producer. All rights, including without limitation, all rights in and to the copyright of the Film not expressly granted hereunder are reserved by Producer.

DEFAULT

In the event of Licensee's default hereunder, in addition to other remedies: (a) Licensee shall immediately cease any use of the Film; and (b) agrees to pay Producer its damages, costs and expenses and any collection costs connected thereto, including the attorney's fees, and legal costs incurred by Producer.

COMPLETE AGREEMENT

This Agreement constitutes the entire agreement between the parties regarding the matters hereunder. This Agreement shall be construed in accordance with, and shall be in all respects, governed by the laws of the State of New York. By paying the invoice and accepting delivery of the Film, Licensee acknowledges that it has read this Agreement, understood its terms and conditions, and has voluntarily accepted its provisions.
